OLD BUSINESS:

- 1. <u>Medical Marijuana</u>: Further discussion on consideration of ordinances tabled until next month due to the absence of key members.
- 2. <u>Food Truck Discussion</u>: Planning Commission Chairman circulated background information on food trucks and how they are regulated by the state.

One significant piece of input was that maximum parking time may be no longer than 3 days. We have the discretion to limit where in the borough that food trucks can go or cannot go. Food trucks will need to follow local regulations regarding food safety. Further discussion at upcoming meetings.
