B. 2021 Spring/Summer Beaver County Regional COG (BCRCOG) Commodities -

Borough Manager presented Council with a list of low bidders for the 2021 Spring/Summer BCRCOG Commodities. The Borough Manager recommends accepting the low bids and authorizing the execution of the agreements. After some review and discussion, on a motion by Mr. Kowal; seconded by Mr. Bucuren to accept the 2021 Spring/Summer BCRCOG Commodities Contracts. Motion was unanimously approved.

Borough Manager mentioned about a possibility of holding a vaccine clinic at the Borough Building.
