- 2. On Page 2 (Section D) and 5 (Section E) of the Notice of Intent, the applicant indicates that there are potentially naturally occurring geologic formations or soil conditions in the project area or surrounding area that are potentially hazardous or could cause or contribute to pollution. The applicant indicates that Section 8 (Geotechnical Report) of the ESCGP-3 Report addresses this matter. The Borough would like to receive a copy of this document so it can be reviewed.
- 3. On Page 20 (Section J) of the Notice of Intent, reference is made to an "attached" description of compliance history. The Borough would like to receive a copy of this attachment so that it can be reviewed.
- 4. On Page 12 (Section H) of the Notice of Intent, the applicant responded that standard PCSM Worksheet #10 is attached to the Notice of Intent. The Borough would like to receive a copy of this worksheet for its review.
