VII <u>New Business</u> Act 14 Notice – B50 to B15 Natural Gas Pipeline Project - on behalf of Energy Transfer Company Northeast Field Services (ETC), Civil & Environmental Consultants (CEC) is applying to the Pennsylvania Department of Environmental Protection (DEP) for authorization under the Erosion and Sediment Control General Permit 3 (ESCGP-3) for the B50 (near Amsler Ridge Road) Pipeline project. CEC is also applying for a Chapter 105 General Permit for Utility Line Crossings (GP-5) and Temporary Road Crossings (GP-8) for stream and wetland impacts associated with this project. The proposed pipeline will connect the existing PER B50 Well Pad and the PER B15 Well Pad (off Hoenig Road) via 2.7 miles natural gas pipeline. The Overall Site Plan is available at the Borough Office. Comments should be sent within 30 days (of October 27<sup>th</sup>, 2021) to PADEP Permitting and Technical Services Section at:

Act 14 Notice – Temporary Above – Ground Waterline – B15 to B46, on behalf of PennEnergy Resources, Civil & Environmental Consultants (CEC) is applying to the Pennsylvania Department of Environmental Protection (PADEP) for Chapter 105 General Permits for Utility Line Crossings (GP-5) and Temporary Toad Crossings (GP-8) for temporary stream and floodway impacts associated with the project. The project consists of installing 1.3 miles of temporary high-density polyethylene (HDPE) waterline. It will transport fresh water from the B15 Well Development Impoundment to the B46 Well Pad, the water will be sourced from PennEnergy's Water Management Plan; no new surface water intakes are associated with this project. The Overall Site Plan is available at the Borough Office. Comments should be sent within 30 days (of October 27<sup>th</sup>, 2021) to PADEP Permitting and Technical Services Section at: Department of Environmental Protection, Office of Oil and Gas Management, Southwest Regional Office, 400 Waterfront Drive, Pittsburgh, PA 15222.
